

Matthew and Sarah Gonnering established the Gonnering Family Donor Advised Endowment to support the future of the Church while teaching their children about the importance of stewardship.



LEAVING A LEGACY

You can continue the impact you have in this life into the next by choosing to support a parish, school, or ministry that has touched your life and helped form your relationship with Jesus Christ. Many of the CDMF's funds were established to honor a loved one passed, celebrate a milestone, and ensure the future of Catholic organizations.



HOW TO MAKE AN ENDOWMENT

So what is an endowment anyway? An endowment is a fund that provides a perpetual source of income. The CDMF manages both endowed and nonendowed funds on behalf of Catholic parishes, schools, and ministries. Donors and organizations identify a charitable interest or organization they wish to support and specify the fund's purpose. While non-endowed funds can be limited in duration, endowments are a permanent resource.

When an initial gift of \$25,000 or more is "endowed," it is invested for longterm growth, and the beneficiary receives a percent distribution each year. Endowments held within the CDMF have up to 4.5% of the fund's 12-quarter rolling averaged total available annually. As the fund grows each year, so does the amount disbursed to the beneficiary. Endowments are a powerful advantage for any organization's financial future.

The initial gift, which may have made an outright impact over three or four years, now has the power to give back for 100+ years. The beneficiary has predictable income from the distribution each year while growing funds for future needs. An endowment is a great way to make any charitable organization more sustainable!

Parishes and individuals can make a gift of cash or securities now. Individuals can leave a planned gift in their will.

STEP 1

CDMF INVESTS THE GIFT TO **GROW THE FUND**

The CDMF utilizes socially responsible screens to uphold Catholic values in investing.



GRANTS AND DISTRIBUTIONS ARE MADE EACH YEAR

A percentage of the fund (typically 4-5%) is available to the beneficiary: a parish, school, or ministry.

STEP 2



THE PROCESS **REPEATS AND** THE IMPACT IS LASTING!

The fund continues to grow through contributions and interest earned and provides financial support for years to come.

STEP 4

BOARD OF DIRECTORS

An independent Board of Directors governs the CDMF.

The board is comprised of the Bishop of Madison, the
Vicar General, parish priests, and lay experts representing
different walks of life, professional experiences, and regions
throughout the diocese. Five standing committees exist to
assist with the CDMF's functions: Executive, Investment,
Development, Audit & Governance, and Grant Review.

INVESTING WITH OPTIMISM FOR THE FUTURE

Dear Friends,

We feel it here at the CDMF, and I'm sure you do, too. There is no mistaking the sense of optimism growing across the Diocese of Madison.

Over the past few years, there has been no shortage of change, and no shortage of challenge-both in our lives and in our faith. But despite all of the change and challenge, and at the risk of sounding overly dramatic, I feel we are in the midst of one of the most exciting times to be alive in the history of the world.

The optimism we feel in the diocese and the growing hope that continues to build around it are directly related to two of the most forward-thinking efforts our diocese has ever undertaken. From the solid groundwork in evangelization and catechesis begun with the Go Make Disciples initiative, to the bold but extremely thoughtful, data-driven, and proactive reorganization of Into the Deep, Bishop Donald J. Hying has set our Catholic faith and the faithful on a course to not only survive, but thrive in these unpredictable times.

For those of you who do not know me, I began work here at the Chancery in the spring of 2022 as the Chief Development Officer for the Diocese of Madison, helping to lead and coordinate fundraising and stewardship efforts across the Diocese.

Earlier this year I was chosen by Bishop Hying and the Board of Directors to also head up the CDMF. It is my absolute privilege and an unbelievable blessing to fulfill both roles. The Bishop's and the Board's confidence and trust in me humbles me beyond words.

The CDMF, organized as its own separate legal entity, exits to provide perpetual funding for the mission and ministries of the Diocese of Madison. Funds here, along with their intent, are protected, and they are invested according to USCCB Catholic investment guidelines and polices.

For 2024 and beyond, we have set some bold goals here at the Foundation. We would like to help and see all of the new pastorates establish endowment funds with the CDMF. We are ramping up promotion of our current funds and increasing our exploration of new fund possibilities. We are simplifying and streamlining our grant application process.

Our long-term goals include increasing the number of funds in the Foundation to 100 and increasing our assets under management to \$250 million. Bold goals to be sure, but as St. Luke tells us, "...nothing is impossible for God" (Lk 1:37).

Navigating the challenges of our times, relatively speaking, is perhaps more difficult now than at any other time in history. To do so, and like our faith, the CDMF remains steadfast in our support of what is good, with our Catholic beliefs and values clearly guiding and supporting our path to the future.

Please consider how you might be able to partner with the CDMF to help memorialize the past, build the present, and transform the future of our universal Church here in the beautiful Diocese of Madison, unified as one Body in Christ.

I offer my heartfelt thanks for your generosity and for all you do to support our amazing Catholic faith. I look forward to continuing the good work of the CDMF and to working with all of you as I wish you and yours a very Merry Christmas and a blessed New Year.
